NEW THIS YEAR, THE COMPANY LAUNCHED ITS SEASON WITH A LIVE SIMULCAST OF THE OPENING NIGHT PERFORMANCE OF "CARMEN". MORE THAN 2,500 PEOPLE CAME OUT FOR THE EVENING TO ENJOY THIS FREE-TO-THE-PUBLIC EVENT HELD OUTDOORS ON HISTORIC INDEPENDENCE PARK MALL.
